## Information on the processing of personal data pursuant to art.13 and 14 EU Reg. 679/2016 ("GDPR")

## Dear patient,

if you decide to undergo the antigenic swab for the detection of the antigen of the Covid-19 virus (hereinafter "antigenic swab"), and, in event of positive outcome, the nasopharyngeal swab for the search for viral RNA by RT-PCR for Covid-19 (hereinafter "swab for viral RNA research"), Santagostino (Società e Salute SpA), as Data Controller, will necessarily process some of your personal data, which you will be communicating to us during the execution phase of the antigenic swab and, if necessary, the swab for viral RNA research, or that a family member may have communicated to us at the time of booking.

By "processing of personal data" we mean any operation concerning any information relating to an identified natural person (in this case, you).

We will keep your data for the minimum time necessary to pursue the purpose of care.

Failure to provide the data will entail the impossibility of execution of the antigenic swab and/ or possibly the swab for viral RNA detection; refusing to undergo the test will not entail any further consequences nor, least of all, compromise any right (including that to health care). We will process your data (personal, contact and health related data) in order to perform the antigenic swab and subsequent investigations for health protection purpose, and possibly for the purpose of carrying out the swab for viral RNA research. This will take place in order to execute the swab to search for viral RNA, based on the agreement with Santagostino and under the responsibility of health professionals subject to secrecy (articles 6.1.b and 9.2. h GDPR).

The data may be processed in the future for research purposes in the medical and epidemiological fields and for statistical analysis, following anonymization (a procedure that makes the information that is used for these purposes irreversibly not attributable to you).

Your personal data will be communicated to the minimum extent necessary to achieve the purposes and always in compliance with current legislation on the processing of personal data: to natural individuals authorized to process (nursing staff), and to service providers related to the health service, which act as Data Processors (IT and accounting service providers), and to all the Regional sanitary institutions (ATS), as required by health protocols and current legislation.
